By enrolling in the BRIF program, your stallion's progeny are now eligible for enrollment in the BRIF. (Barrel Racing Incentive Fund). The BRIF, established in 2011, is combined the HFBI (Hawki Futurity Breeders Incentive program) beginning in 2017 the BRIF will offer BOTH futurity incentive money AND open incentive money and 10% of the purse at ALL BRIF events will be paid back to stallion owners of those placing in the BRIF bonus. As the program grows we will be able to add more events to our schedule. Please see the website for the tentative schedule of 2018 events. (The new schedule includes 2 futurity events for 2018 in addition to 3-4 open events).

The annual fee is \$350/stallion. The list is limited to 75 stallions. A deceased stallion (that has previously paid into the program with no lapse in enrollment) may pay the deceased stallion fee of \$250. These stallions will not be counted in the 75 stallion limit. If a stallion is deceased but has not kept up on annual enrollment fees, they can pay into the program at the full price \$350 (these stallions will not be counted in the 75 stallion max total).

If anyone other than the current owner listed on the stallion's papers pays the stallion into the program, the owner must sign a release form on this page that gives that person permission to enroll the stallion and receive the stallion owner winnings for the calendar year.

10% of the total stallion fee will be held for administration and advertising each year by Double B Productions, LLC. No refunds will be offered for any reason.
